## Video script

**VIVIANA** Who was that?

MARTA That's the famous Mr. Corny Flowers.

VIVIANA (kidding) I think he likes you, Mom.

MARTA Finish your homework.

Mr. Cook sits at his desk and leans over his P.A. microphone.

MR. COOK Good morning, everyone. I just wanted to let you know that Mr. Flores will be passing out

VIVIANA I like the literacy program. I want to help people learn to read and write.

MARQUEZ Ah, that's wonderful. Wonderful. Kim enters. Now that we're all here, let's discuss

something that's been in the news lately. Sexual harassment.

Marquez takes the sheet off. The board reveals - "SEXUAL Harassment"

MARTA Cornelio, I'm busy. What do you want?

You need to fill out your absence report.

Can't I do it later? I need to finish the orders.

**CORNELIO** Mr. Cook wants it now. Of course, if you don't want to do it, then I can report you.

WORK EXPERIENCE CLASS

MARQUEZ Sexual harassment can mean a number of things. Like invading someone's personal

space or standing too close to someone. Or making unwanted sexual advances or

comments.

**JUAN CARLOS** Oh, come on. Girls like it when guys do that.

**VIVIANA** That's not true.

**FACTORY** 

MARTA Here's my absence report.

CORNELIO Mmm. Honey, you're looking very sexy right now. I like it when you work hard. How would

you like to join me for lunch.

MARTA I am not hungry, Cornelio. Thank you. And I told you before, my name is Marta.

**WORK EXPERIENCE CLASS** 

**DREW** Of course, they do.

**MARQUEZ** Do all girls like that type of attention?

JUAN CARLOS Of course they do. No, we don't.

You think it's the only way to get our attention.

You can't get our attention that way. I promise.

**JUAN CARLOS** Very funny. You like it and you know it.

MARQUEZ This may come as a surprise to you, Juan Carlos. But that kind of behavior can get you

fired or put you in jail. Sexual harassment is a serious crime.

**KIM** Can a man be sexually harassed?

**MARQUEZ** Yes. Sexual harassment victims can be both male or female.

VIVIANA What do you do? Who do you call when you've been a victim of sexual harassment?

MARQUEZ Well, most companies have policies against sexual harassment.

But what if it's the boss that's guilty of sexual harassment? **KIM** Then you should report it to that person's boss. Also, there are a number of public **MAROUEZ** agencies and legal aid foundations you can go to. And if you see it happen, you should report it. MARTA 'S WORKSTATION It's the end of the day. Marta has put together many orders (boxes, bags, whatever) Cornelio comes in. He's carrying a folder. Let me see your orders. Did you miss me? Do all the boxes have the same contents? **CORNELIO MARTA** Of course. CORNELIO Then they're all wrong. **MARTA** What? Unbeknownst to Marta, Cornelio takes out a different set of orders from his folder. CORNELIO Look. You're missing three other items and the sequence is not right. **MARTA** (frantic) That's impossible. I counted them twice. I don't understand. MARTA I had a hard day at work. Cornelio kept on bothering me and I couldn't think. I filled out all the

orders incorrectly.

**VIVIANA** You filled the orders incorrectly? You never do that!

MARTA I know.

**VIVIANA** You said Cornelio was bothering you? What was he doing?

MARTA He was having fun with me. He was calling me names like "Honey", "Sweetheart". He was

standing right next to me. I felt so uncomfortable, I couldn't concentrate.

Viviana thinks for a second.

VIVIANA That's sexual harassment! He can't treat you like that.

MARTA Cornelio is mad because I don't pay attention to him.

VIVIANA It doesn't matter why he's mad. He's wrong. And you have to do something about it and fast.

**MARTA** What can I do? He's my boss. I'll get fired.

VIVIANA Talk to his boss. Cornelio is the one who will be fired. This can't go on. This has to stop

Marta thinks for a moment realizing Viviana is right.

MARTA Maybe you're right.

MR. COOK'S OFFICE

**CORNELIO** That's right, Mr. Cook.

MR. COOK (KNOCK ON DOOR) Ah, come in, Ms. Cardona. I, uh, wanted to talk to you.

MARTA I need to talk to you too, Sir.

MR. COOK It seems that Mr. Flores here wants to file a formal complaint against you.

MARTA Against me? Why?
MR. COOK Uh, sexual harassment.

Suspenseful moment. Disbelief in her look. Total "see how you get out of this one" on

Corny.

MARTA Me? Sexual harassment?

**CORNELIO** That's right. After all of your mistakes yesterday, you asked me to hide them in exchange for

sexual favors.

Marta cannot believe it!

MARTA You, no good...

MR. COOK Now, now. Let's not get excited. Just calm down.

Mr. Cook is interrupted by his secretary on the speakerphone system.

**SECRETARY** Mr. Cook, you're needed on the floor right away.

(O.S.)

Mr. Cook presses a button to respond. We see the P.A. gadget.

MR. COOK (to the PA) Can it wait a moment?

SECRETARY

No, Mr. Cook. Right away.

(O.S.)

MR. COOK

I'll be right there. (to Marta and Cornelio) I can't believe these people. I'll be right back.

Mr. Cook exits leaving Cornelio and Marta alone.

CORNELIO Sure, Mr. Cook. MARTA Oh, you are one...

CORNELIO Ah, ah. Who is smiling now, my dear Martita? Oh, don't look so upset. I'll tell you what. I'll

make a deal with you. You go out with me and I'll drop the charges.

MARTA And if I don't.

**CORNELIO** If you don't, well, if you don't -- then I'll file a complaint and you'll lose your job. A brilliant

idea.

MARTA I will fight you.

**CORNELIO** (laughing) Fight me? Fight what? Uh? You have nothing. Nothing. Who do you think Mr.

Cook is going to believe? Me? Or you?

MARTA If I go out with you, what will you tell Mr. Cook?

CORNELIO Ah, Mr. Cook. Mr. Cook. I'll just tell him everything was a misunderstanding. So, do we have

a deal?

Marta is in a nasty predicament. And, just as she's ready to utter words, the Wizard

appears.

#### Sexual Harassment

Sexual harassment is a very serious issue. Sexual harassment happens when an individual or individuals create a tense or uncomfortable work environment, which keeps a worker or workers from performing their duties. Both men and women can be guilty of sexual harassment. Some examples of sexual harassment:

- Making unwanted sexual advances toward a person
- Using demeaning names to address someone (honey, baby, etc).
- Coercing workers into sexual favors, to keep a job or for promotion
- Using sexually explicit language in a professional environment
- Making comments about the sexual appearance of an individual.

let's talk about adverbs of manner. Adverbs of manner tell us how an action is done. For example, this is a special get well potion from my mother. I will drink it slowly. The adverb slowly tells us how I am drinking the potion. Now, I will drink it quickly. Oooh. Quickly is an

adverb, too. Let's look at other examples.

**MARTA** I always work diligently.

## **Adverbs of Manner**

Adverbs of manner tell us <u>how</u> an action takes place, or how something is done. For example:

- Marta works <u>diligently</u>.
  - Diligently is the adverb of manner because it tells us how Marta works.
     In this case, diligently tells us that Marta works hard.
- Marta works <u>slowly</u>.

o The adverb is slowly because it tells us how Marta works.

Usually (another adverb), words that end with "ly" are adverbs. More examples:

• Carefully, closely, heavily, incorrectly, fully, openly, rapidly, lightly.

**CORNELIO** Because nobody says no to Corny Flowers. **MARTA** Oooh. But you lied. I never harassed you.

CORNELIO (laughing) I know. That was a good one. And the best part is you didn't make a mistake

with your orders yesterday. I changed them at the last minute. And that old goat, Mr. Cook,

didn't even notice. Oh, Corny. You're so brilliant. Corny Flowers is a brilliant man.

MARTA You mean you set me up?

CORNELIO (laughing again) Yes. But that doesn't matter now because I have you. I have you right

where I want. Oh, hello, uh, Mr. Cook. Marta and I were just...

Mr. Cooks walks in. Cornelio stops laughing.

MR. COOK Save it, Mr. Flores. This old goat heard everything. I only have two things to say. You're

Everyone outside rejoices. A victory for the dedicated workers. Cornelio leaves in a hurry.
